## ORDER NO. 7 REQUIRING RE-NOTICING AND REVISING THE PROCEDURAL SCHEDULE

On September 25, 2015, Order No. 6 was issued in this proceeding, requiring the City of Austin (COA) to provide correct notice of this application consistent with Public Utility Commission of Texas (Commission) Staff's September 18, 2015 pleading and attached memorandum. Order No. 6 also adopted a procedural schedule that included an October 15, 2015 deadline for COA to file an affidavit of notice to affected customers and a copy of the notice actually issued, along with the accompanying map. COA has not responded to Order No. 6.

On November 18, 2015, Commission Staff responded to Order No. 6, noting that COA has not responded. Commission Staff again recommended that COA be instructed to provide correct notice of this application consistent with Commission Staff's September 18, 2015 pleading and attached memorandum, and to file affidavits attesting that notice was completed as required, or face potential dismissal of the application. Commission Staff also proposed a revised procedural schedule.

Consistent with Commission Staff's recommendation, COA shall provide correct notice of this application consistent with Commission Staff's September 18, 2015 pleading and attached memorandum and submit proof of notice by the deadline established herein below. Further, COA is advised that failure to provide notice as required and to file the required proof of notice could result in dismissal of this application. Finally, the following revised procedural schedule is approved, as proposed:

Deadline for COA to submit an affidavit of notice to affected customers, the notice actually issued, and the attached map	December 15, 2015

Deadline for affected parties, other than Commission Staff, to file comments, intervene, or request a hearing	30 days after notice is issued
Deadline for Commission Staff to request a hearing or to file a supplemental procedural schedule	January 26, 2016
