JOINT MOTION TO ADMIT EVIDENCE

Commission Staff ("Staff") of the Public Utility Commission of Texas ("Commission") and Aqua Water Supply Corporation ("Aqua WSC") file this Joint Motion to Admit Evidence. Staff and Aqua WSC request that certain evidence be admitted into the record in support of their filed Proposed Notice of Approval. In support of their Joint Motion to Admit Evidence, Staff and Aqua WSC state the following:

I. BACKGROUND

On January 28, 2015, Aqua WSC filed an application with the Commission. In its application, Aqua WSC requested an amendment to its water certificate of convenience and necessity (CCN No. 10294) in Bastrop County to decertify sixty-three (63) acres within the city limits of the City of Bastrop, and currently receiving water utility service from the City of Bastrop.

On July 22, 2015, Staff filed its Final Recommendation. Staff recommended that the Commission approve Aqua WSC's application and the amendment of Aqua WSC's water CCN No. 10294. Additionally, Staff recommended that the Commission find that: (1) no protests to Aqua WSC's application were received; (2) Aqua WSC has never provided service in the area that is the subject of Aqua WSC's application; and (3) amending Aqua WSC's water CCN No. 10294 is necessary for the service, accommodation, convenience, or safety of the public.

On August 11, 2015, Staff and Aqua WSC filed their Proposed Notice of Approval.


