- iv. Aqua WSC is informed by the Texas Comptroller of Public Accounts that it is no longer issuing "Certificates of Account Status" to exempt entities. Therefore, Aqua is attaching a Franchise Tax Account Status from the Comptroller's website, as instructed by a representative of the Comptroller's Office. See Attachment C.

Q. 2.A.

The area affected by this Application is within the city limits of the City of Bastrop, Texas, having been annexed by the City over a number of years beginning in 2004. The area is being developed as a commercial/retail area. Beginning in 2005, the City of Bastrop has been providing retail water utility service to the commercial/retail customers in the area. Applicant also believes that the City of Bastrop is providing retail sewer service to the commercial/retail customers, as well. To Applicant's knowledge, there are no residential developments or customers in the area that is the subject of this Application.

Q.2.B.

It is unlikely that any of the existing commercial/retail entities in the area that is the subject of this Application will seek retail water utility services from Aqua, as all of the current development is receiving such service from the City of Bastrop.

Q.3.C.

The area contains 63.1 acres, and for ease of reference in the Application is primarily divided into two tracts.

Tract 1 is 52.3 acres, and is bordered on the south by a strip of land 300 feet wide that parallels the north right-of-way of Highway 71. On the west, this tract is bordered by Duff Road, on the north by Blakey Lane, and on the east by Edward Bureson Lane.

Tract 2 is 10.8 acres, and is bordered on the south by Highway 71 right-of-way and on the east by McCoys Lumber and Duff Drive.

Q.5.

Information about the “Existing System” is not considered to be relevant, as Aqua is not seeking to have additional territory added to its CCN, but is removing territory therefrom that is currently being served by another retail public utility – the City of Bastrop. Aqua does not have information about the City of Bastrop’s system, nor does it know the number of meters on Bastrop’s current system or in the area that is the subject of this Application. However, Aqua is aware of at least fourteen water meters that have been installed in the area by the City, which includes both irrigation meters and meters to serve stores, restaurants, and banks in the area. These meters range in size from $\frac{3}{4}$ ” to 2.”

Q.5.G.

The granting of the Application will result in the following: (1) the CCN maps will thereafter accurately reflect who is providing retail utility service in the area; (2) Aqua will no longer be responsible for providing continuous and adequate service to customers who receive utility service from a different retail public utility; and (3) the public and property owners will not be confused by the existence of a CCN that bears no relationship to the actual provision of retail water utility service.

Q.5.I.

Because this Application is requesting decertification of an area, the ability of Aqua to provide service to the area is not germane. The City of Bastrop is currently providing service to all consumers of retail water services in the area. Aqua assumes that such service is adequate, as development has been continuing unabated since 2005. The area is developing as commercial/retail, and from a visual inspection appears to be reaching full development.

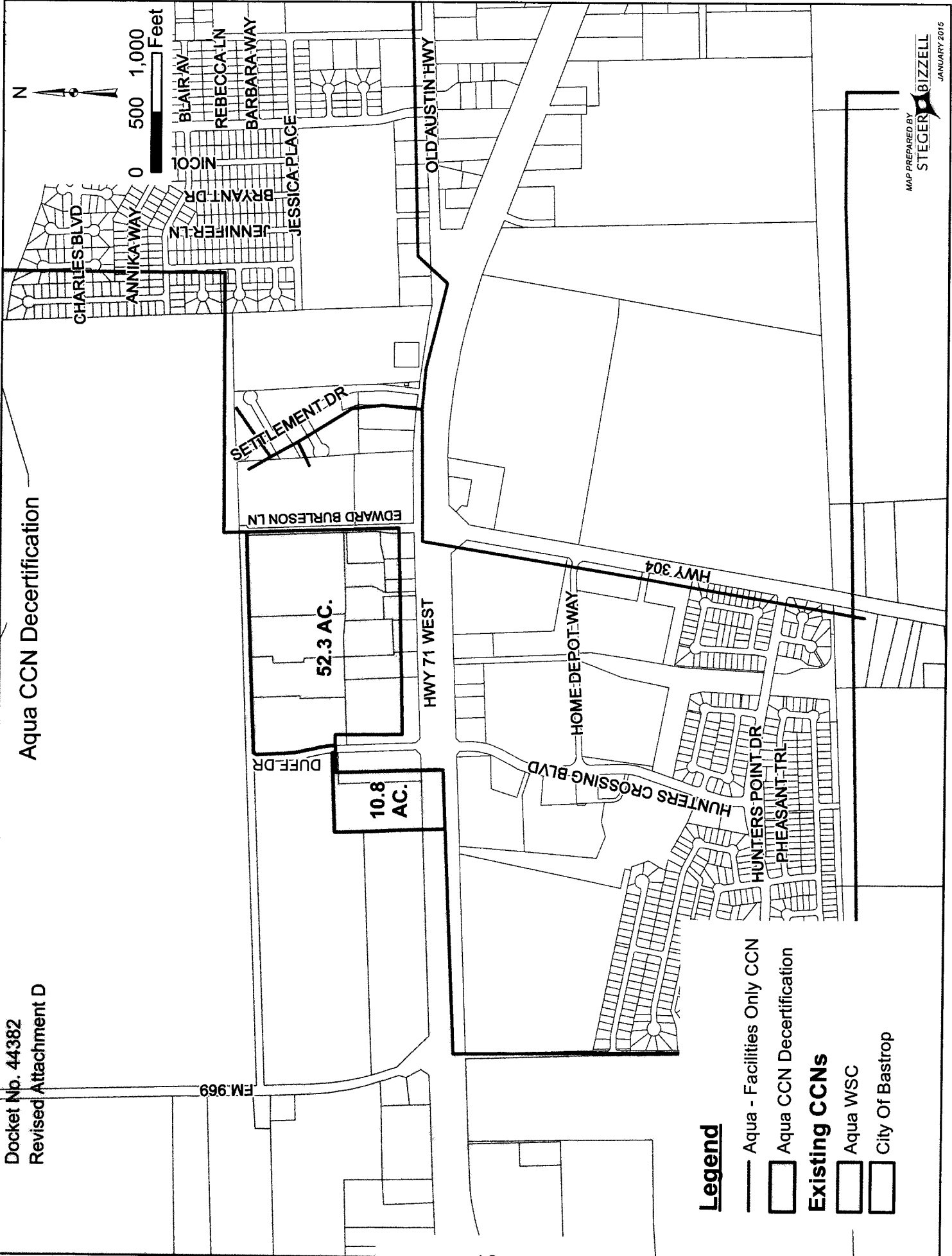
