# CITY OF BEEVILLE'S PLEA TO THE COMMISSION'S AUTHORITY TO SET INTERIM RATES PRIOR TO A HEARING ON THE PUBLIC INTEREST

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

NOW COMES, the City of Beeville ("Beeville"), the respondent in the above styled and docketed matter, and files this Plea to the Commission's Authority to Set Interim Rates Prior to a Hearing on the Public Interest.

#### I. APPLICABLE LAW

Beeville previously filed a motion to abate this wholesale rate case filed under Texas Water Code, section 13.043(f), pursuant to P.U.C. Subst. R. 124.131(d) on the grounds that Beeville and the petitioner do not agree on whether or not the protested rate is charged pursuant to a written contract. Unless and until this issue is resolved by the courts and, if the rate is set pursuant to contract, the Commission does not have jurisdiction to set interim rates prior to making a public interest finding pursuant to P.U.C. SUBST. R. 24.133. <sup>1</sup>

#### II. CONCLUSION AND PRAYER

WHEREFORE, PREMISES CONSIDERED, Beeville respectfully requests the Administrative Law Judge find that the Commission lacks jurisdiction to set interim rates unless and until the courts resolve the issue of whether the challenged rates are set pursuant to contract
