DISCUSSION OF FISCAL YEAR 2011-2012 BUDGET FOR STREET MAINTENANCE FUNDS Councilmembers were provided an example of a Street Maintenance Fund Budget for Fiscal Year 2011-2012. The City Manager added that he had included a request from Councilman John Fulghum for approving the resurfacing of Adams Street. While going through the material provided, the City Manager advised that he had also included two (2) estimates for Adams Street for an overlay and one (1) for seal coating. He advised that the figures provided pertained to work for Adams Street, Kennedy and Inez Streets. In conclusion he reminded the Council that the date for the renewal of the Street Maintenance Sales Tax is April 2013 and that to renew this ability to obtain funding from the 4B Sales Tax, the Council will have to hold an election in 2012.

This matter was acknowledged to be a discussion item and no further action was taken.

CONSIDERATION OF REQUEST FROM THE FIRST UNITED METHODIST CHURCH FOR CLOSURE OF CLEVELAND STREET FROM ST. MARY'S TO JEFFERSON ON OCTOBER 15, 2011 Councilmembers were provided a copy of a letter from Mr. David L. Morgan, a member of the Board of Trustees for the First United Methodist Church of Beeville requesting temporary closure of East Cleveland Street from St. Mary's to Jefferson Street on October 15, 2012 and for celebration of their 150 years in the City.

Mr. Morgan, in the audience, advised he was present on behalf of the Church and explained that the 150th Year Celebration is very important for their Church adding that their Bishop will be attending the ceremony. He concluded that this request is strictly for the safety of those attendants and that other traffic will still be able to have egress, ingress to their parking area since it is the same time the annual Western Week Parade is held.

It was acknowledged that the request was for closure between the hours of 11:30 a.m. to $5.00~\mathrm{p.m}$

Upon a motion by Councilman Fulghum, seconded by Councilman Carabajal the Council unanimously granted the First United Methodist Church their request.

CONSIDERATION OF FILLING VACANCY LEFT BY TODD ROBERSON IN THE CITY'S PLANNING AND ZONING COMMISSION The Council acknowledged that at the previous regular meeting they had accepted the resignation of Mr. Todd Roberson who was in the City's Planning and Zoning Commission. They also acknowledged they did not have a replacement at the time and therefore were not ready to take action.

Upon a motion by Councilman Fulghum, seconded by Councilwoman Spires the Council unanimously tabled further action on this matter.

APPOINTMENTS/REAPPOINTMENT OF TWO (2) MEMBERS TO THE HOUSING STANDARDS BOARD

The City Building Inspector reported to the Council that the two (2) members that are up for appointment/reappointment were Mr. Adolf Loya and Johnny Padilla. Mr. Holland further advised that upon contacting Mr. Loya, Mr. Loya had expressed a desire to not continue his service and that Mr. Padilla had expressed a willingness to continue serving if it the Council's desire.

Upon a motion by Councilwoman Spires, seconded by Councilman Carabajal the Council unanimously reappointed Mr. Johnny Padilla to another term in the City's Housing Standards Board and tabled the appointment of a member to replace Mr. Adolf Loya.

CONSIDERATION OF NOMINATING TO THE BEE COUNTY APPRAISAL DISTRICT BOARD OF DIRECTORS

The City Manager advised the Council that nomination of individuals to be considered for the Bee County Appraisal District's Board of Directors can be done now but that if they were not ready they had until October 14, 2011.

Upon a motion by Councilman Carabajal, seconded by Councilman Fulghum the Council unanimously tabled action until their next regular meeting of October 11, 2011.

CONSIDERATION OF REQUEST FROM THE POLICE DEPARTMENT TO TEMPORARILY CLOSE CORPUS CHRISTI STREET FROM WASHINGTON TO ST. MARY'S FOR NATIONAL NIGHT OUT Councilmembers were informed by the City Manager that Police Chief Trevino is requesting temporary street closure of Corpus Christi Street between Washington and St. Mary's on October 4, 2011 from 6:00 p.m. to 8:00 p.m. for the National Night Out activities.

Upon a motion by Councilman Fulghum, seconded by Councilwoman Spires the Council unanimously granted the Police Department and Chief the request for temporary closure of the 100 Block of West Corpus Christi Street

REVIEW AND CONSIDERATION OF ACTION FOR THE HOTEL/MOTEL FUND GENERAL APPLICATION FOR SPECIAL EVENTS

The City Manager advised the Council that this particular item had been placed on the agenda at the request of Councilman Carabajal. He added that it is probably a good idea to review the City's Application for these H.O.T. Funds every now and then to better scrutinize and maximize the use of said H.O.T. Funds.

Councilman Carabajal introduced the concept of establishing a committee to look over the applications now being used and that said committee bring back to the Council possible amendments to make the best use of the H.O.T. Funds. He concluded he would be willing to serve in such a committee. Councilman Fulghum volunteered to serve in said committee as well.

Upon a motion by Mayor Pro-Temp Scotten, seconded by Councilwoman Spires the Council unanimously appointed the committee comprised of Councilmembers Carabajal and Fulghum along with the City Manager or his designee to review the current applications now being handed out to applicants for H.O.T. Funds and that said committee bring back their ideas to the entire Council.

CITY MANAGER REPORTS STATUS ON VETERANS MEMORIAL PARK PUMP STATION STATUS REPORT ON PARK IMPROVEMENT PROGRAM In providing a status report on the Veterans Memorial Park Pump Station, the City Manager advised that the project completion is within two (2) weeks away.

In reporting on the park improvement program, the City Manager reported that the program was "on track" and that Mr. John Longoria has been working with Amstar and will have a report for the Council at their October 11, 2011 meeting. He concluded that Mr. Longoria will also be addressing the Beeville Independent School District Board of Directors on the same subject.

EXECUTIVE SESSIONS

Mayor Pro-Temp Scotten announced that the City Council would be going into a closed executive session pursuant to Local Government Code Section 551.071(1)(A) to discuss pending litigation and on a separate matter pursuant to Texas Local Government Code Section 551 071 to consult with the City Attorney on to separate matters. The time was 7:14 p.m.

Mayor Pro-Temp Scotten reconvened the open meeting at 8:13 p.m. and announced that no formal action would be taken concerning the first session in the discussion of pending litigation. He also advised that the Council would also take no formal action concerning the third matter addressing the Council's consultation with the City Attorney. Mayor Pro-Temp Scotten then entertained action concerning the matter discussed in executive session concerning the TD Water Supply Agreement.

Upon a motion by Councilman Carabajal, seconded by Councilman Fulghum the Council unanimously authorized the administration to enter into a Letter of Agreement with Mathews and Freeland, Attorneys for the City's sale of its treated wastewater effluent from the Wastewater Treatment Plant to TD Water Resource Management, L.L.C.

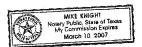
