**CITY OF BEEVILLE'S REQUEST TO SET UP CONFERENCE BRIDGE

TO THE HONORABLE STEVEN D. ARNOLD ADMINISTRATIVE LAW JUDGE:

On April 14, 2015, the Administrative Law Judge issued SOAH Order No. 3 setting a hearing on April 30, 2015 at 10:00 Central Time, with the explanation that he would call the Counsel of Record listed on the Service List. As the parties' representatives and counsel are not in one place, and other representatives may desire to monitor the hearing, the City of Beeville requests that it be permitted to set up a conference bridge that the parties may call, and so that the ALJ and Counsel can all participate.
