# **COMMISSION STAFF'S REQUEST FOR PROCEDURAL SCHEDULE**

**COMES NOW** the Staff (Staff) of the Public Utility Commission of Texas, representing the public interest and files this Request for procedural Schedule and would show the following:

#### I. BACKGROUND

On February 24, 2015, Maryanne Theriot filed a complaint regarding the election procedures of the Etoile Water Supply Corporation (Etoile). Specifically, Ms. Theriot alleges that Etoile inappropriately changed the signature requirement in the application for a director.

## II. STAFF'S REQUEST FOR HEARING

Pursuant to Texas Water Code (TWC) § 13.004 and 16 Tex. Admin Code § 24.35 (TAC), the Commission has jurisdiction over water supply corporations under certain conditions.<sup>1</sup> Staff respectfully requests that the administrative law judge issue a procedural schedule requiring Etoile to file a response, and Staff to file a statement of position. Staff proposes the following procedural schedule:

Deadline for Etoile to file a response to the complaint	October 23, 2015
Deadline for Staff to file a statement of position	November 20, 2015

(1) is failing to conduct annual or special meetings in compliance with Section 67.007; or (2) is operating in a manner that does not comply with the requirements for classifications as a nonprofit water supply or sewer service corporation prescribed by Sections 13.002(11) and (24).
