COMMISSION RECOMMENDATION ON SUFFICIENCY OF NOTICE ISSUED

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this Recommendation on Sufficiency, and would show the following:

I. BACKGROUND

On February 26, 2015, Founders Reserve Community Association, Inc. (Founders or Applicant) filed with the Commission an application (Application) to obtain new water and sewer certificates of convenience and necessity in Montgomery County, Texas.

Order No. 5 deemed the Application sufficient for filing and instructed the Applicant to issue notice consistent with Staff's June 26, 2015 instructions. The Applicant filed the notices issued and affidavits of notice on August 5, 2015. Order No. 5 provided that Staff would file a supplemental recommendation by August 15, 2015. Therefore, this pleading is timely filed.

II. RECOMMENDATION ON SUFFICIENCY OF NOTICE ISSUED

As explained in the memorandum (Attachment A) of Leila Guerrero and Tracy Harbour of the Water Utilities Division, the Applicant did not list everyone it was instructed to notice by Staff's June 26, 2015 instructions in its affidavits of notice. The Commission also received a letter from Linda Kaye Rice on August 6, 2015 stating that she received individual notice from the Applicant but did not receive an attached map that was referenced in the notice, which Staff also instructed the Applicant to provide with each individual notice. Therefore, Staff recommends that the Applicant be ordered to issue a complete notice to those entities not receiving a notice and reissue a complete notice to the parties that received incomplete notice. Applicant should provide additional affidavits verifying compliance with notice.

IV. PROPOSED PROCEDURAL SCHEDULE

Staff proposes the following procedural schedule:

Deadline for Applicant to submit the	September 15, 2015
Affidavits of Notice and the individual notice	1
issued with the accompanying map.	
Deadline to file, comments, intervene, or request a hearing.	30 days from the issuance of notice
Deadline for Staff to file an additional procedural schedule with hard deadlines ¹	October 20, 2015

Staff respectfully requests the entry of an order consistent with the above recommendation.



On February 26, 2015, Founders Reserve Community Association, Inc., (Applicant) filed with the Public Utility Commission of Texas (Commission) an application to obtain a water and sewer Certificates of Convenience and Necessity (CCNs) in Montgomery County, Texas. This application is being reviewed under 16 Tex. Admin. Code §§24.102 - 24.107 (TAC) and Tex. Water Code § 13.241 (TWC)

On June 26, 2015, Staff filed a recommendation deeming the application sufficient for filing and further recommended the Applicant be ordered to do provide proper public notice.

On June 29, 2015, the Commission issued Order No. 5 requiring the Applicant to file affidavit of notice by July 24, 2015.

On August 5, 2015, the Applicant filed affidavits of notice in the PUC's filing interchange. Upon review of the filed documents, Staff found that they are insufficient due to the following:

• The Applicant failed to provide notice to North Harris County Regional Water Authority, Northampton MUD, and Northwest Harris County MUD 19.

Based on the foregoing, Staff recommends that Applicant be ordered to return a copy of the actual notices sent to North Harris County Regional Water Authority, Northampton MUD, and Northwest Harris County MUD 19 along with a signed affidavit that the notice was given.
