COMMISSION STAFF'S RESPONSE TO ORDER NO. 6

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this Response to Order No. 6. In support thereof, Staff shows the following:

I. BACKGROUND

On February 26, 2015, Founders Reserve Community Association, Inc. (Founders or Applicant) filed with the Commission an application (Application) to obtain new water and sewer certificates of convenience and necessity in Montgomery County, Texas.

The Applicant filed the notices issued and affidavits of notice on August 5, 2015. Based on Staff's recommendation, Order No. 6 found error with the notice issued and instructed the Applicant to reissue notice and file evidence of notice by September 15, 2015. On August 25, 2015, Staff filed requests for information (RFIs) with the Applicant.

II. RECOMMENDATION

To date, the Applicant has filed no evidence of the reissuance of notice, nor has the Applicant responded to Staff's RFIs. Therefore, Staff recommends that the Applicant file all these materials or potentially face dismissal of the Application.
