**COMMISSION STAFF'S RESPONSE TO ORDER NO. 8
PROPOSED ADDITIONAL PROCEDURAL SCHEDULE**

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this Commission Staff's Response to Order No. 8. In support thereof, Staff shows the following:

I. BACKGROUND

On February 26, 2015, Founders Reserve Community Association, Inc. (Founders or Applicant) filed with the Commission an application (Application) to obtain new water and sewer certificates of convenience and necessity in Montgomery County, Texas.

On August 25, 2015, Staff filed requests for information (RFIs) with the Applicant. Applicant filed responses on October 27, 2015. Order No. 8 instructed Staff to file an additional procedural schedule no later than December 15, 2015. Therefore, this pleading is timely filed.

II. PROPOSED PROCEDURAL SCHEDULE


Because of complexities contained in the information filed in response to RFIs, Staff is in the process of setting up a telephone conference with the Applicant to gain clarification on some of the responses. Staff left a message for the Applicant on December 9, 2015, but has not yet heard back. Staff will continue to communicate with the Applicant in order to resolve the issues raised. Therefore Staff proposes to file a supplemental recommendation and/or procedural schedule by January, 2015.


