COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest and files this Recommendation on Sufficiency, and would show the following:

I. BACKGROUND

On March 6, 2015, Oak Forest Highlands, Inc. (Highlands or Applicant) and Forest Oaks Mobile Homes, LLC (Forest Oaks or Applicant) filed an application (Application) for the sale, transfer, or merger of facilities and certificate of convenience and necessity rights in Travis County. Specifically, Forest Oaks seeks approval to acquire all of the water system assets of Highlands. Highlands' water certificate of convenience and necessity (CCN) No. 12086 will be transferred to Forest Oaks.

In Order No. 2, the Administrative Law Judge (ALJ) deemed the Application incomplete and allowed the Applicant until April 24, 2015 to cure several deficiencies noted by Staff in its April 6, 2015 filing. The Applicant made three supplemental filings. Order No. 2 allowed Staff until May 22, 2015 to file a supplemental recommendation on sufficiency and a procedural schedule. Therefore, this pleading is timely filed.

II. RECOMMENDATION

As detailed in the attached memorandum of Emily Sears and Suzanne Burt (Attachment A) of the Water Utilities Division, Staff recommends that the Application should now be deemed sufficient for filing. The Applicant's supplemental filings cured the Application's previously noted deficiencies. Attachment A also recommends that the Applicant should provide public notice and provides instructions on how notice should be

issued. Attachment B provides a sample form notice to the customers, Attachment C provides a sample form notice of publication, and Attachment D provides sample form affidavits of notice.

III. PROPOSED PROCEDURAL SCHEDULE

Staff proposes the following procedural schedule:

Deadline for Applicant's to submit proof of	June 26, 2015

Deadline to intervene, file comments, or request a hearing	30 days after notice is issued
Deadline for Staff to file a recommendation, request for hearing, and/or an additional procedural schedule with hard deadlines ¹	August 11, 2015

III. CONCLUSION

Staff requests the ALJ issue an order consistent with this pleading.


On March 6, 2015 Forest Oaks Mobile Homes, LLC (Applicant) filed an application to purchase facilities and transfer Certificate of Convenience and Necessity (CCN) No. 12086 of Oak Forest Highlands, Inc., in Travis County, Texas. The Application was filed pursuant to Chapter 13.251 of the Texas Water Code (TWC), and Chapter 24 of 16 Texas Administrative Code (TAC).

The application is sufficient for filing. The notice for publication and the notice to current customers, neighboring systems and cities are attached. The Applicant should be ordered to:

- 1) Notice the following entities, in addition to those entities listed in the application, located within a 2mile buffer of the proposed service areas requested with this application:
 - a) Woods of Bear Creek Water Co., Inc. (CCN 11907)
 - b) Guadalupe-Blanco River Authority (No CCN)
 - c) Lower Colorado River Authority (No CCN)
 - d) Shady Hollow MUD (No CCN)
- 2) Provide the correct notice of the application to the following:
 - a) any districts, groundwater conservation districts, counties, utilities, cities, cities with an extraterritorial jurisdiction within two (2) miles of the proposed service areas;
 - b) any city with an extraterritorial jurisdiction which overlaps the proposed service areas; and
 - c) any customers transferred, or other affected parties in the requested area.
 - d) published notice to the public which must be published once each week for two (2) consecutive weeks in a newspaper of general circulation in Travis County;
- 3) Include a copy of a map showing the proposed service areas with the individual notices to neighboring utilities, customers and other affected parties. It is the Applicant's burden to provide an accurate map delineating the proposed service areas with each individual notice. Information related to districts including addresses can be obtained by the Applicant from the TCEQ web site located at http://www14.tceq.texas.gov/iwud/

By June 26, 2015, the Applicant should submit a copy of the actual notice issued, the map issued with the individual mailed notice, and the signed affidavits (copies attached), indicating that the notice was given.

For newspaper notice, the Applicant should provide a tear sheet of the actual newspaper publication for each week along with a publisher's affidavit as proof that sufficient notice was provided.



A public hearing will be held only if a legally sufficient hearing request is received or if the Commission on its own motion requests a hearing. Only those individuals who submit a written hearing request or a written request to be notified if a hearing is set will receive notice if a

hearing is scheduled.

If a public hearing is requested, Commission will not transfer the CCN and will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, the SOAH will submit a recommendation to the Commission for final decision. If an evidentiary hearing is held, it will be a legal proceeding similar to a civil trial in state district court.
