ORDER NO. 3 DEEMING APPLICATION SUFFICIENT; ADDRESSING NOTICE AND ESTABLISHING PROCEDURAL SCHEDULE

I. Application

On April 17 and May 5, 2015, Oak Forest Highlands, Inc. (Highlands) and Forest Oaks Mobile Homes, LLC (Forest Oaks) (jointly Applicants) filed supplemental information to cure deficiencies in their application as identified by Public Utility Commission of Texas (Commission) Staff.

II. Administrative Completeness

On May 21, 2015, Commission Staff filed additional comments on the sufficiency of the amended application and notice. Commission Staff finds that the amended application and notice are sufficient for further review. Consistent with Commission Staff's recommendation, the application and notice are deemed administratively complete.

III. Notice

Commission Staff recommended that the parties provide notice and submit signed affidavits indicating that notice has been given, along with a copy of the actual notices issued within 30 days of the date of notice and last publication date. Applicants shall provide notice as described in Commission Staff's May 21, 2015 filing and consistent with the criteria outlined in the attached memorandum of Emily Sears and Suzanne Burt of the Commission's Water Utility Regulation Division, using the forms attached to the Commission Staff memorandum. Applicants shall file affidavits evidencing proof of notice by the deadline set forth below.

--- IV. Procedural-Schedule---

The following procedural schedule is adopted:

Deadline for Applicants to file affidavits attesting to mailed and published notice along with a copy of the notice sent	June 26, 2015
Deadline for affected persons to file a written protest or to intervene, deadline for affected persons to file comments, and deadline to request a hearing on the merits	Within 30 days of mailing or publication of notice, whichever occurs later
Deadline for Commission Staff to file an updated procedural schedule or request a hearing	August 11, 2015
