PCSI'S RESPONSE TO ORDER NO. 6

Comes now, Professional Contract Services, Inc. ("PCSI") and files this Response to Order No. 6. In support of this filing, PCSI states the following:

I. BACKGROUND

In Order No. 6, the Public Utility Commission of Texas (the "Commission") established a deadline of September 1, 2015 for PCSI to clarify whether it intends to pursue or withdraw its previous conditional request for hearing relative to the Application for Sale, Transfer or Merger of a Retail Public Utility (the "Transfer Application") filed with the Commission on March 6, 2015, by Oak Forest Highlands, Inc. and Forest Oaks Mobile Homes, LLC ("Transferee") in connection with Certificate of Convenience and Necessity No. 12086 (the "CCN").

II. RESPONSE AND WITHDRAWAL

PCSI does not intend to pursue its conditional request for hearing. Accordingly, PCSI hereby withdraws: (i) its request for a public hearing and (ii) its objection to the Transfer Application. PCSI is withdrawing in reliance upon that certain Agreement to Amend CCN dated as of August 27, 2015, by and between PCSI and Transferee, wherein Transferee has covenanted to apply for and pursue an amendment of the CCN whereby the certificated area is limited to only the 6.73 acres owned by Transferee (or its affiliate), as described in the deed from Texana

Properties, Inc. to Forest Oaks MHC, LLC, recorded at 2014156103 in the Official Public Records of Travis County, Texas.
