

# WATER SYSTEM ANALYSIS FOR BLUE BLAZES RANCH Dripping Springs, Texas

PROJECT DESCRIPTION: Blue Blazes Ranch is a planned 35.02 acre mixed commercial and residential development. A majority of the site is planned commercial with the remaining 5.21 acres to be developed into Single Family Residential lots.

ANALYSIS PARAMETERS: The projected water demand is based upon the Blue Blazes Ranch Land Use Plan and the regulations outlined in *Chapter 290 Public Drinking Water* produced by the Texas Commission on Environmental Quality. Further assumptions affecting the water demand were based upon the projected commercial space land use for each lot.

WATER DEMAND CALCULATIONS: The water demands for each lot were calculated based on the land use type and the assumed number of people per lot. The max day demand per person was established from Table A in Chapter 290. The peak hour demand was determined by multiplying the max day demand by the peaking factor of 1.25 for elevated storage systems.

## Attachment 7 – Financial Information

Although the City of Dripping of Dripping Springs has a Water CCN, the City not yet provided water service and has not constructed its water system. A standalone water system, with a master wholesale water meter, will be constructed by the Developer of the Blue Blazes Development. To the extent that the City of Dripping Springs incurs any costs in construction, operation and maintenance, management, and operation of the water system, the City has the authority to recover such costs through its rate ordinances.

The City of Dripping Springs will adopt a rate schedule, service rules, and extension policies after construction is complete and before water service is provided. 




