

## JOINT MOTION TO WITHDRAW REQUEST

#### TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

COME NOW the City of Heath ("Heath") and Forney Lake Water Supply Corporation ("Forney Lake") and file this Joint Motion to Withdraw Request and in support thereof would show the following:

- 1. On October 31, 2017 the City of Heath and Forney Lake Water Supply Corporation executed a Texas Water Code 13.255(a) single service certification and service area transfer agreement in order to grant Heath single certification to all water utility service area within its corporate limits currently certificated to or served by Forney Lake and to transfer water utility service area and customers and to convey facilities, easements, and other property from Forney Lake to the City.
- 2. On January 23, 2018 the City of Heath filed the §13.255(a) agreement with the Public Utility Commission and requested that the terms of the agreement be incorporated into the respective CCN's of the parties.
- 3. On July 2, 2018 the Commission approved the City of Heath's application and amended Heath's CCN No. 12060 and Forney Lake's CCN No. 10086 to reflect the agreement between the parties.
- 4. Pursuant to the terms of the §13.255(a) agreement Heath and Forney Lake have completed and closed on the conveyances covered by the agreement.
- 5. Following the closing on the conveyances covered by the §13.255(a) Agreement all matters in dispute in this docket have been resolved.

NOW, THEREFORE, The City of Heath and Forney Lake Water Supply Corporation jointly request that the application in this docket be withdrawn as moot.
