DEFINITIONS

- 1) "Heath", "the Company" or "you" refers to the City of Heath and any person acting or purporting to act on their behalf, including without limitation, attorneys, agents, advisors, investigators, representatives, employees or other persons.

 - a. Please demonstrate that your existing public drinking water systems comply with the minimum requirements for public drinking water systems promulgated by the Texas Commission on Environmental Quality (TCEQ).
 - b. Please demonstrate that you will comply with the minimum requirements for public drinking water systems promulgated by the TCEQ with respect to the area affected by your application.
- STAFF 1-3 Please refer to 16 TAC § 24.120(n). Please demonstrate that you have obtained a finding from the TCEQ that you will demonstrate compliance with the TCEQ's minimum requirement for public drinking water systems pursuant to 30 TAC Chapter 290, Subchapter D.
