## **CITY OF HEATH'S STATUS REPORT**

## TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

COMES NOW the City of Heath ("Heath") and files this status report as required by Order No. 5, and in support thereof will show the following:

The City of Heath and Forney Lake Water Supply Corporation (Forney Lake) continue to make progress in finalizing and implementing an agreement pursuant to Texas Water Code § 13.255(a). Forney Lake has provided Heath the information needed to file with PUC an application to approve the Water Code §13.255(a) agreement between the parties. That application was filed on January 23, 2018 and assigned docket number 47979.

The most recent actions in docket 47979 are that PUC staff has filed its final recommendations for approval and supplemental final recommendation on April 30 and May 14 respectively, and Heath has filed a Joint Motion to Admit Evidence and Proposed Notice of Approval on May 9. After an order approving Heath's application is filed, Heath and Forney Lake will schedule a closing on the transaction. Within five business days following closing, the parties will file joint motions requesting that Docket 44541 be dismissed as moot.

All parties have reviewed and concur with this status report.
