ORDER NO. 7  
ADOPTING PROCEDURAL SCHEDULE  
AND CANCELLING PRE-HEARING CONFERENCE

The Public Utility Commission of Texas, (Commission) will conduct a hearing on the merits in this docket on **Thursday, September 24, 2015**, following the open meeting in the Commissioners' Hearing Room, 1701 N. Congress Ave., 7<sup>th</sup> Floor, Austin, Texas. On July 7, 2015, the Parties submitted an agreed proposed procedural schedule.

**I. Procedural Schedule**

The Administrative Law Judge has modified the agreed proposed procedural schedule to accommodate a prehearing conference prior to the hearing date and to allow for receipt of responsive filings in a timely fashion prior to the hearing. The following schedule is adopted:

Discovery shall be governed by the Commission's procedural rules at Subchapter H, except that responses to requests for information (RFIs) and requests for admission related to Intervenor Direct are due 14 calendar days after receipt, and responses to requests for information and requests for admission related to Staff's Direct, Intervenor and Staff Cross-Rebuttal, and Sharyland's Rebuttal shall be provided within seven calendar days of receipt.

In addition to the original plus 11 copies of testimony required under 16 Tex. Admin. Code § 22.71(c)(7) (TAC), **an additional nine (9) copies of testimony** should be filed for distribution to the Commissioners. Pleadings and other filings shall be deemed filed when the proper number of copies are presented to the Commission filing clerk for filing pursuant to 16 TAC § 22.71(c)(7).

## II. Cancelling Prehearing Conference

At the request of the Parties the prehearing conference scheduled for Thursday, July 9, 2015, at 10:00 a.m. is cancelled.
