**ORDER NO. 3  
DEEMING APPLICATION ADMINISTRATIVELY COMPLETE,  
ADDRESSING NOTICE; AND ESTABLISHING PROCEDURAL SCHEDULE**

**I. Application**

On April 8, 2015, YES Prep Public Schools (YES Prep) and Suburban Utility Co. (Suburban) (jointly Applicants) filed with the Public Utility Commission of Texas (Commission) a joint application to decertify YES Prep's property from Suburban's service area Certificate of Convenience and Necessity No. 10835. On May 12, 2015, Order No. 2 was issued finding the application administratively incomplete and deficient, and establishing a deadline and opportunity to cure. On May 15, 2015, YES Prep amended the application.

**II. Commission Staff Recommendation on Administrative Completeness**

On May 27, 2015, Commission Staff filed additional comments on the sufficiency of the application as amended. Commission Staff finds that Applicants' application as amended is sufficient for further review. Consistent with Commission Staff's recommendation, Applicants' petition is deemed administratively complete.

**III. Commission Staff Recommendation on Notice**

Commission Staff has reviewed Applicants' proposed notice with regard to applicable statutes and rules, and recommends Applicants send the notice as specifically described in Commission Staff's May 27, 2015 filing and the attached memorandum of Elisabeth English and Suzanne Burt of the Commission's Water Utility Regulation Division.

Consistent with Commission Staff's recommendation, Applicants shall provide notice as directed by Commission Staff using the forms attached to Commission Staff's memorandum. Applicants shall file affidavits evidencing proof of notice by the deadline set forth below.

#### IV. Procedural Schedule

The following procedural schedule as proposed by Commission Staff is adopted:

Event	Date
Deadline for Applicants to provide the Commission with affidavit of provision of notice and copy of the actual notice sent; deadline to submit a publishers' affidavit of notice	June 30, 2015
Deadline for Interventions, filing of comments, or for Intervenors to request a hearing	30 days after the mailing or publication of notice, whichever occurs later
Deadline for Commission Staff to file an updated procedural schedule based upon the date notice was mailed	30 days after the provision of notice
