
COMES NOW YES Prep Public Schools, Inc. ("YES Prep") and files this Copy of the Publisher's Affidavit and Request for Extension to File the Original Publisher's Affidavit.

1. Pursuant to Order No. 3, YES Prep published notice of the application to decertify YES Prep property from Suburban Utility CO.'s ("Suburban's") retail water certificated service area (CCN No. 10835) in the Houston Chronicle on June 16, 2015 and June 23, 2015.
2. The Houston Chronicle placed the original publisher's affidavit in the mail to counsel for YES Prep on June 25, 2015, and it has not yet been delivered to counsel's office in Austin, Texas.

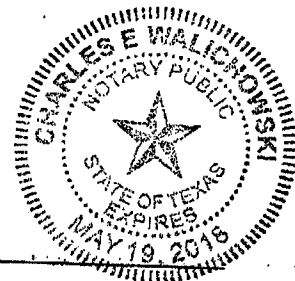

**NOTICE OF APPLICATION
FOR CERTIFICATE OF
CONVENIENCE AND
NECESSITY (CCN) TO
PROVIDE WATER UTILITY
SERVICE IN HARRIS
COUNTY, TEXAS**

YES Prep Public Schools, Inc. has filed an application for a CCN to amend CCN No. 10835 and to de-certify a portion of Suburban Utility CO. with the Public Utility Commission of Texas to provide water utility service in Harris County.

The proposed utility service is located approximately 2 miles southeast of downtown Aldine, Texas, and is generally bounded on the north by Strawn Road; on the east by Aldine Westfield Road; on the south by Lauder Road; and on the west by Chrisman Road.

The total area being requested includes approximately 18 acres and 1 current customer. A copy of the proposed service area map is available at: YES Prep Public Schools, Inc., 6201 Bonhomme, Ste 168N, Houston, TX 77036; (713) 967-9000.

A request for a public hearing must be in writing. You must state (1) your name, mailing address, and daytime telephone number; (2) the applicant's name, application number or another recognizable reference to this application; (3) the statement, "I/we request a public hearing"; (4) a brief description of how you or the persons you represent, would be adversely affected by the granting of the application for a CCN; and (5) your proposed adjustment to the application or CCN which would satisfy your concerns and cause you to withdraw your request for a hearing.

within thirty (30) days from the date of this publication or notice. A public hearing will be held only if a legally sufficient hearing request is received or if the commission on its own motion requests a hearing. Only those individuals who submit a written hearing request or a written request to be notified if a hearing is set will receive notice if a hearing is scheduled.

If a public hearing is requested, the commission will not issue the CCN and will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, the SOAH will submit a recommendation to the commission for final decision. If an evidentiary hearing is held, it will be a legal proceeding similar to a civil trial in state district court.

If you are a landowner with a tract of land at least 25 acres or more, that is partially or wholly located within the pro-

When a tract of land of at least 25 acres or more, that is partially or wholly located within the proposed area, you may request to be excluded from the proposed area (or "opt out") by providing written notice to the commission within thirty (30) days from the date that notice was provided by the applicant. All requests to opt out of the requested service area must include a scaled, general location map and a metes and bounds description of the tract of land.

Persons who meet the requirements to opt out, and wish to request this option should file the required documents with the:
