JOINT MOTION TO ADMIT EVIDENCE

Public Utility Commission of Texas (Commission) Staff; YES Prep Public Schools, Inc. (YES Prep); and Suburban Utility Company (Suburban) (collectively, Applicants) file this Motion to Admit Evidence. Commission Staff and Applicants request that certain evidence be admitted into the record in support of their filed Proposed Notice of Approval. In support of their Motion to Admit Evidence, Staff and Applicants state the following:

I. Background

On April 8, 2015, Applicants filed an application to decertify YES Prep's north central campus from Suburban's water certificate of convenience and necessity (CCN) No. 10835 with the Commission. The CCN No. 10835 service area is located in Harris County, Texas.

On October 27, 2015, Commission Staff filed its Recommendation on Final Disposition. Commission Staff recommended that the Commission approve the application and approve the requested removal of YES Prep's property from Suburban's CCN.

On November 16, 2015, Commission Staff and Applicants filed their Proposed Notice of Approval.
