# ORDER NO. 6 DEEMING APPLICATION ADMINISTRATIVELY COMPLETE; ESTABLISHING PROCEDURAL SCHEDULE

### I. Application

On April 16, 2015, the City of Belton (Belton) filed with the Public Utility Commission of Texas (Commission) an application to amend its sewer certificate of convenience and necessity (CCN) No. 20444 in Bell County. Order No. 3 and Order No. 4, issued on June 4, 2015 and July 28, 2015 respectively, deemed this application deficient, but provided Belton an opportunity to cure the identified deficiencies. Belton filed supplemental information to cure deficiencies in the application on August 7, 2015 and September 25, 2015.

# II. Commission Staff Recommendation on Administrative Completeness

On October 1, 2015, Commission Staff responded to Order No. 5. Commission Staff stated that Belton has cured all application and notice deficiencies, therefore recommends that the application is administratively complete. Consistent with Commission Staff's recommendation, Belton's application is deemed administratively complete.

## III. Commission Staff Recommendation on Notice

Commission Staff recommended that Belton be instructed to provide notice and submit signed affidavits indicating that notice was given, along with a copy of the actual notices issued, signed affidavits and a copy of the map issued with the notice. Consistent with Commission Staff's recommendation, Belton shall provide notice in the manner and as specifically described in Commission Staff's October 1, 2015 pleading and the attached memorandum of Jolie Mathis and Tracy Harbour of the Commission's Water Utility Regulation Division, using the attached forms.



## IV. Procedural Schedule

The following procedural schedule as proposed by Commission Staff is adopted:

Deadline for intervention; deadline for intervenors to file comments or request a hearing on the merits	Within 30 days of mailing or publication of notice, whichever occurs later
