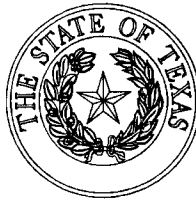

**RE: Tariff Control No. 44661 – Application of Consolidated Communications of Texas (CCTX) to Revise Tariff Pages Pursuant to 16 Tex. Admin. Code § 26.208**

**NOTICE OF APROVAL**

On April 20, 2015, Consolidated Communications of Texas (CCTX) filed an application with the Public Utility Commission of Texas (Commission) to make revisions to its General Exchange Tariff. The revisions increase residential 1-Party Stand Alone, 1-Party Bundle, Trunk Stand Alone and Trunk Bundle rates in compliance with the rate rebalancing Order in Docket No. 41097.<sup>1</sup> CCTX requested an effective date of June 1, 2015.

On May 15, 2015, Commission Staff filed its recommendation for approval of CCTX's application. Commission Staff determined that the application for rate increase and the revised proposed notice are in compliance with 16 Tex. Admin. Code § 26.208 and with the Order in Docket No. 41097.

Consistent with Commission Staff's recommendation, the following tariff sheets are approved, effective June 1, 2015:<sup>2</sup>
