COMMISSION STAFF'S APPROVAL OF REQUEST

I. BACKGROUND

On April 28, 2015, Providence Village Water Control and Improvement District of Denton County (WCID) filed a request to update its CCN records to show the WCID as the holder of CCN Nos. 13020 and 20922. The previous name on the certificates is Denton County Fresh Water Supply District No. 9 (District). Previously, the District applied for and received approval from the Texas Commission on Environmental Quality (TCEQ) to amend its name. The TCEQ issued an order on April 13, 2010 approving the name change. In its request, the WCID provided documentation showing the creation of the District, approval for the name change, and proof of notice of publication of the name change.

II. COMMISSION STAFF'S APPROVAL OF NAME CHANGE

Commission Staff has reviewed the WCID's request. As supported by the attached memorandum from Lisa Fuentes, of the Water Utilities Division, Staff finds that the WCID has provided sufficient evidence supporting the name change and recommends that the proposed changes are reasonable. Staff approves the request. Amended certificates are attached.

On April 29, 20154, Providence Village Water Control and Improvement District of Denton County (WCID) filed a request with the Public Utility Commission of Texas to change the names on Certificate of Convenience and Necessity Nos. 13020 and 20922, currently issued to Denton County Fresh Water Supply District No. 9.

The WCID's filing includes an order issued by the Texas Commission on Environmental Quality approving the request by Denton County Fresh Water Supply District No. 9 to change its name to Providence Village Water Control and Improvement District of Denton County on April 13, 2010, and an affidavit demonstrating publication of notice of the name change in a newspaper of generation circulation in Denton County on July 14, 2010.
