ORDER NO. 3 DEEMING APPLICATION ADMINISTRATIVELY COMPLETE, ADDRESSING NOTICE; AND ESTABLISHING PROCEDURAL SCHEDULE

I. Application

On May 1, 2015, Crystal Clear Water Supply Corporation (Crystal Clear WSC) filed with the Public Utility Commission of Texas (Commission) an application to obtain a new sewer certificate of convenience and necessity in Comal County, Texas. On June 3, 2015, Order No. 2 was issued finding the application administratively incomplete and deficient, and establishing a deadline and opportunity to cure. On June 12, 2015, Crystal Clear WSC filed an amended application.

II. Administrative Completeness

On July 2, 2015, Commission Staff filed additional comments on the sufficiency of the application. Commission Staff finds that Crystal Clear WSC's application is sufficient for further review. Consistent with Commission Staff's recommendation, Crystal Clear WSC's application is deemed administratively complete.

III. Notice

Commission Staff has reviewed Crystal Clear WSC's proposed notice with regard to applicable statutes and rules, and recommends Crystal Clear WSC send the notice as described in Commission Staff's July 2, 2015 filing and the attached memorandum of Sean Scaff and Komal Patel of the Commission's Water Utility Regulation Division, using the forms attached to the Commission Staff memorandum.

Consistent with Staff's recommendation, Crystal Clear WSC shall provide notice as described in Staff's July 2, 2015 recommendation and file affidavits evidencing proof of notice by the deadline set forth below.

IV. Procedural Schedule

The following procedural schedule as proposed by Commission Staff is adopted:

Event	Date
Deadline for Crystal Clear WSC to provide the Commission with the Affidavits of Notice, the individual notice issued with the accompanying map, and the published notice	August 3, 2015
Deadline for affected persons to file a written protest or to intervene, deadline for affected persons to file comments, and deadline to request a hearing on the merits	30 days after Crystal Clear WSC mails or publishes notice, whichever occurs later
Deadline for Commission Staff to file an additional procedural schedule with hard deadlines	September 7, 2015
