- 1. My name is Jeremiah W. Cunningham. I am employed by Southwestern Public Service Company ("SPS") as Regulatory Case Specialist. I am authorized to make this affidavit and I have personal knowledge of the facts stated herein.
- 2. On May 1, 2015, SPS filed with the Public Utility Commission of Texas an application to adjust its Energy Efficiency Cost Recovery Factor ("EECRF"). The application has been assigned Docket No. 44698.
- 3.
