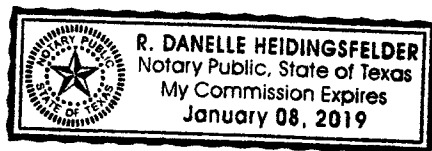


BEFORE ME, the undersigned authority, on this day personally appeared Jeremiah W. Cunningham, who being by me first duly sworn, on oath, deposed and said the following:

1. My name is Jeremiah W. Cunningham. I am employed by Southwestern Public Service Company ("SPS") as Regulatory Case Specialist. I am authorized to make this affidavit and I have personal knowledge of the facts stated herein.
2. On May 1, 2015, SPS filed with the Public Utility Commission of Texas an application to adjust its Energy Efficiency Cost Recovery Factor ("EECRF"). The application has been assigned Docket No. 44698.
3. On May 1 and May 4, 2015, SPS served notice of the EECRF filing by regular first-class mail, hand delivery, and Federal Express to the parties to SPS's most recent completed base rate case, Docket No. 42004; to all parties that participated in the case in which SPS's 2015 EECRF was adjusted, Docket No. 42454; and to the state agency that administers the federal weatherization program, which is the Texas Department of Housing and Community Affairs ("TDHCA"). 
