**SOAH ORDER NO. 7

On August 25, 2015, AEP Central, on behalf of itself, staff (Staff) of the Public Utility Commission of Texas (Commission), and Cities Served by AEP Texas Central Company (Cities), filed Joint Motion to Admit Evidence and Remand to the Commission.
