BEFORE ME, the undersigned notary, personally appeared RL Denison, the affiant, a person who is known to me. After administering an oath, the affiant testified that:


- 1. My name is RL Denison. I am over the age of eighteen years, of sound mind, and am capable of making this affidavit. The facts stated in this affidavit are within my personal knowledge and are true and correct.
- 2. I am President of INTERNATIONAL CENTER FOR ENTREPRENEURIAL DEVELOPMENT, INC. ("ICED"), which is the sole owner of KWIK KOPY CORPORATION, the petitioner in the abovecaptioned matter. ICED owns approximately 93 acres of land (the "Property"), made up of parcels held in either the name ICED or KWIK KOPY CORPORATION (its wholly owned subsidiary). A portion of Property which is held in the name KWIK KOPY CORPORATION is located within boundaries of Water CCN. No. 13203 issued to Aqua Texas, Inc. The Property is located within Harris County, Texas and is over 25 acres in size. Attachment A is a true and correct copy of a map identifying the Property, its location, and the area of the CCN. As indicated in the legend of Attachment A.
- 3. The Property is not receiving water service from Aqua Texas, Inc. or any other water service provider, neither ICED nor KWIK KOPY CORPORATION has requested water service from Aqua Texas, Inc. or paid any fees or charges to initiate or maintain water service, and there are no billing records or other documents indicating an existing account for the Property. I have reviewed surveys and deed records for the Property and there are no utility easements or other indication that any water lines or other facilities of Aqua Texas, Inc. located on the Property. I have visited the Property, and I have not observed, and am not aware of, any work performed by Aqua, Texas, Inc. to extend service to the Property.
- 4. I request that the Public Utility Commission of Texas release this Property from Water CCN No. 13203.




