COMMISSION STAFF'S RESPONSE TO ORDER NO. 2

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Response to Order No. 2, and would show the following:

I. BACKGROUND

On May 18, 2015, MSEC Enterprises, Inc. (MSEC or Applicant) filed an application to amend sewer certificate of convenience and necessity (CCN) No. 20984 in Montgomery County. In Order No. 2 was issued on June 19, 2015, in which the administrative law judge found the application to be administratively incomplete and deficient, and required, on or before July 17, 2015, for MSEC to amend its application to cure the deficiencies identified by Staff, and for Staff, on or before August 17, 2015, to file a supplemental recommendation regarding administrative completeness of the amended application along with a proposed procedural schedule, if appropriate.

II. COMMENTS ON ADMINISTRATIVE COMPLETENESS

Staff has reviewed the additional information submitted by MSEC. Staff recommends that the application be declared administratively complete, as supported by the attached memorandum from Fred Bednarski, Financial & Managerial Review Specialist, and Komal Patel, GIS Specialist in the Water Utilities Division.

MSEC Enterprises, Inc. (Applicant) filed an application to amend its sewer Certificate of Convenience and Necessity (CCN) No. 20984 and in Montgomery County, pursuant to Texas Water Code (TWC) §§ 13.242 thru 13.250 and P.U.C. SUBST. R. 24.101 thru 24.107.

I have reviewed the above referenced application and have found that it is sufficient in the content provided; therefore, I recommend that the application be deemed administratively complete. I further recommend the following:

- 1) The Applicant be ordered to provide correct notice of the application to the following:
 - a) any districts, groundwater conservation districts, counties, utilities, cities, cities with an extraterritorial jurisdiction within two (2) miles of the proposed service area;
 - b) any city with an extraterritorial jurisdiction which overlaps the proposed service area;
 - c) landowners with more than 25 acres and any affected parties in the proposed CCN area. The landowner information may be obtained from the county appraisal district tax rolls for the county or counties in which the proposed CCN lies; and
 - d) published notice once each week for two (2) consecutive weeks in a newspaper of general circulation in Montgomery County;
- 2) In addition to the neighboring entities listed in the application, the Applicant must provide notice to: Martin Creek MUD, San Jacinto River Authority (SJRA), Stanley Lake MUD, City of Conroe, City of Montgomery, Montgomery County, and the Lonestar Groundwater Conservation District (GCD)
- 3) The Applicant must include copy of a map showing the proposed service area with the individual notices to neighboring utilities, other affected parties and each landowner. It is the Applicant's burden to provide an accurate map delineating the proposed area with each individual notice. Information related to districts including addresses can be obtained by the Applicant from the TCEQ web site located at <u>http://www14.tceq.texas.gov/iwud/</u>.
- 4) The Applicant be ordered to return a copy of the actual notices sent with attached signed affidavits that the notice was given within 30 days of providing notice.
