**JOINT PROPOSED PROCEDURAL SCHEDULE**

COMES NOW, Texas-New Mexico Power Company ("TNMP") and files this Joint Proposed Procedural Schedule. On June 9, 2015, the ALJ issued SOAH Order Number 1 stating that, in lieu of a prehearing conference, the parties may file a jointly-proposed procedural schedule on or before July 2, 2015. On June 12, 2015, the Staff of the Public Utility Commission ("Staff") filed a Request for Hearing in this matter. TNMP, Staff, and Intervenor Cities Served by Texas-New Mexico Power Company ("Cities") have agreed to this joint proposed procedural schedule for a contested hearing process.
