I. ADOPTING PROCEDURAL SCHEDULE

Order No. 1 required the parties to file an agreed procedural schedule for this proceeding. On June 15, 2015, Oncor Electric Delivery Company, LLC (Oncor) filed a schedule that it represented had been approved by Staff of the Public Utility Commission of Texas (Commission) and the Steering Committee of Cities Served by Oncor (Cities), the only other parties to this proceeding. 
## II. NOTICE OF HEARING ON THE MERITS
