DEFINITIONS

- A. "Quadvest" or "you" refers to the Quadvest, L.P. and any person acting or purporting to act on their behalf, including without limitation, attorneys, agents, advisors, investigators, representatives, employees or other persons.

- Staff 1-1 On page 16 of the application referring to Lake Point Estates, the PWS number provided, "0796189," does not bring up any information in the TCEQ database. Lake Pointe Estates does not come up in any TCEQ search functions either. Please provide:
 - i. information documenting that this is an active and TCEQ approved water system, such as a core data form; and
 - ii. the most recent CCI inspection of the facility if available
- Please explain how Quadvest will provide water and sewer services to the neighborhood of Lake Point Estates, when 100% of water and sewer services are currently provided by Fort Bend County MUD 37.
- Staff 1-3 If Fort Bend Mud 37 will continue to provide water and sewer utility services to the area after the Sale, Transfer, Merger takes place and Quadvest owns the CCN area, please provide a contract or written agreement in support
