JOINT STATUS REPORT

Pursuant to Order No. 4 issued in this docket and 16 Tex. Admin. Code § 24.109(g), Quadvest, L.P. ("Quadvest") hereby files, for itself and with permission from Westside Water, LLC ("Westside"), this Joint Status Report, and states the following:

- 1. As reported in previous Joint Status Reports regarding the process of obtaining a public water system ("PWS") certification for Lake Pointe Estates, Quadvest indicated that Ince Engineering, LLC submitted a packet to the Texas Commission on Environmental Quality ("TCEQ") Water Supply Division Utilities, Technical Review Team, on December 10, 2015 providing the information necessary to combine the Lake Point Estates underground utilities with Quadvest's existing "Bridlewood PWS #0790350." As an update, Quadvest hereby reports that on February 19, 2016 Quadvest received a letter from the TCEQ Water Supply Division, Plan and Technical Review Section, Plan Review Team, identifying deficiencies in the application to be addressed in order for TCEQ to issue the PWS certification. Quadvest has been working with TCEQ representatives since receipt of the letter to address the identified issues to the satisfaction of TCEQ.
- 2. Quadvest continues to anticipate obtaining the PWS certificate from TCEQ well in advance of the October 19, 2016 deadline to submit all closing documents in this matter.
