## **STATUS REPORT**

Pursuant to Order No. 4 issued in this docket and 16 Tex. Admin. Code § 24.109(g), Quadvest, L.P. ("Quadvest") hereby files, for itself (having not obtained permission to file on behalf of Westside Water, LLC as of the time of this filing), this Status Report, and states the following:

- 1. As reported in previous Joint Status Reports regarding the process of obtaining a public water system ("PWS") certification for Lake Pointe Estates, Quadvest indicated that Ince Engineering, LLC submitted a packet to the Texas Commission on Environmental Quality ("TCEQ") Water Supply Division Utilities, Technical Review Team, on December 10, 2015 providing the information necessary to combine the Lake Point Estates underground utilities with Quadvest's existing "Bridlewood PWS #0790350." As reported on March 16, 2016, Quadvest received a letter from the TCEQ Water Supply Division, Plan and Technical Review Section, Plan Review Team, on February 19, 2016 identifying deficiencies in the application to be addressed in order for TCEQ to issue the PWS certification. Quadvest submitted a formal response to the TCEQ letter on March 29, 2016, following informal discussions with TCEQ staff regarding the deficiencies. Communications between Quadvest representatives and TCEQ staff have been ongoing since that March 29, 2016 submittal in pursuit of final TCEQ approval of the application.
- 2. Quadvest continues to anticipate obtaining the PWS certificate from TCEQ well in advance of the October 19, 2016 deadline to submit all closing documents in this matter.
