## JOINT STATUS REPORT

Pursuant to Order No. 4 issued in this docket and 16 Tex. Admin. Code § 24.109(g), Quadvest, L.P. ("Quadvest") hereby files, for itself and with permission from Westside Water, LLC ("Westside"), this Joint Status Report, and states the following:

Order No. 4 directed the parties as follows: "In an effort to finalize this case as soon as possible, beginning November 18, 2015, and continuing monthly thereafter, Quadvest and Westside shall file an update regarding the status of the efforts to conclude the transaction and to submit documents evidencing the transaction closing and the disposition of customer deposits." On July 5, 2016, Administrative Law Judge Huhn issued Order No. 5 (Docket Item No. 32) finding the closing documentation submitted by the parties to be sufficient and complete and setting a procedural schedule for the remainder of the proceeding. Order No. 5 reflects the parties' satisfaction of the condition for which they were directed to provide status reports.

Accordingly, Quadvest and Westside submit that Order No. 4 does not require any further status reports. The parties will not be filing further status reports unless directed by the Administrative Law Judge.
