

Dear Sirs:

We were notified by Debbie Tamayo on Friday, November 13, 2015 that there were some insufficient information on the CCN application and needed to correct some mapping requirements as well. Attached is one original and seven copies for work order No. 5. Below are the comments addressed:

Mapping Content

- 1.) A large scale (detail) map only showing the proposed water service area with enough detail to accurately locate the service area in the vicinity of surrounding roads, streets, and highways.
 - a. A large scale map only showing the proposed water service area with enough detail is attached.
- 2.) Revised digital data only including the proposed water service area in a drawing (DWG) file format on a data disk (CD). The revised digital data must remove all overlaps with the following existing CCNs including [Fouke WSC (10488), Prichett WSC (10478), Big Woods Springs Water (12367) and their own existing CCN 10476].
 - a. A revised CD with a DWG file is attached. The existing CCN service areas have been erased and are not shown in the digital file as requested.
- 3.) A complete list of all utilities, districts and municipalities located within a 2-mile buffer of proposed water service area. Also, include the groundwater conservation districts and counties located within the requested proposed water service area.
 - a. A complete list of all the existing utilities, districts, and municipalities located in a 2-mile buffer has been attached. As of the November 10, 2015 map found on TCEQ's website there is no groundwater conservation district listed for Wood County and Upshur County.
- 4.) It appears Sharon WSC is currently delinquent in paying the Texas Commission on Environmental Quality's (TCEQ) regulatory assessment fees pursuant to TWC 5.701(n)(1). These fees must be paid in full in order to complete the review of the application.
 - a. Debbie Tamayo has informed us that the fees are current and Sharon WSC does not owe any fees at this time anymore.

Please advise if you need more information.
