

We received Order No. 8 May 14, 2016 that there were some insufficient details that needed to be corrected on the mapping requirements. I spoke with Tracy Montes, and she fixed the overlapping issues we were having and informed me about the facility +200 lines. Below are the facility +200 lines we are including in Sharon WSC proposed CCN area.

- The intersection of FM 2088 and CR 4590, Sharon WSC facility +200 line on CR 4590 is now incorporated into the proposed service area.
- On FM 312, south approximately 4,300 feet south of FM 2088, Sharon WSC facility +200 line is now incorporated into the proposed service area.
- The intersection of FM 1002 and Lamb Road, Sharon WSC facility +200 line is now incorporated into the proposed service area.
- The new total area after incorporating three (3) of Sharon WSC facility +200 lines is approximately 21,328 acres.
