DEFINITIONS

Staff 2-1 Please provide Sharon WSC's audited financial statements for calendar year 2015.

Staff 2-1 Pursuant to pursuant to 16 Tex. Admin. Code § 24.105(a)(6) provide a capital improvements plan (CIP plan), including a budget and estimated time line for construction of all facilities necessary to provide full service to the entire proposed service area (23,500+ acres). The CIP plan should be keyed to maps showing where such facilities will be located to provide service to the requested area at a cost of \$16.67 per linear foot (Applicant's response to Staff's 1st request for information, item 14 of this docket).

Please provide any voluminous data electronically especially the general ledgers and financial statements in excel format.


