# THE CITY OF HACKBERRY, TEXAS' REQUEST FOR EXTENSION

**COMES NOW** the City of Hackberry, Texas (the "Applicant") and files this Request for Extension, and would show the following:

## I. BACKGROUND

On June 9, 2015, the the Applicant, filed with the Public Utility Commission of Texas, (the "Commission") an application to obtain a new sewer Certificate of Convenience and Necessity (CCN) in Denton County, Texas. On July 9, 2015, Commission Staff filed comments on the application identifying deficiencies in the Application. On July 13, 2015, the administrative law judge (ALJ) issued Order No. 2, which required the Applicant to supplement the application with information to cure the deficiencies identified by Commission Staff by August 9, 2015, and that Staff file a supplemental recommendation on administrative completeness of the amended application, if appropriate, by September 9, 2015.

#### II. REQUEST FOR EXTENSION

Pursuant to P.U.C. PROC. R. 22.4(b), Applicant may request the time for filing any documents be extended for good cause. The Applicant's engineer is reviewing the alleged deficiencies and is in the process of determining what actions should and can be taken to cure the alleged deficiencies. Therefore, Applicant requests the ALJ find good cause to extend the procedural schedule as set out below.
