**COMMISSION STAFF'S RESPONSE TO ORDER NO. 3**

Comes Now, Staff of the Public Utility Commission of Texas (Staff) and files this Response to Order No. 3. In support thereof, Staff shows following:

**I. BACKGROUND**

On June 9, 2015, Double Diamond Properties Construction Co. dba Rock Creek Resort (Applicant) filed with the Public Utility Commission of Texas (Commission) an application (Application) to obtain a new water Certificate of Convenience and Necessity (CCN) in Grayson County, Texas.

Order No. 3 allowed the Applicant until August 26, 2015 to provide proof of notice. The Applicant timely filed affidavits of notice and samples of the notices issued with the Commission on August 19, 2015. Order No. 3 allowed Staff until September 29, 2015 to file a recommendation on sufficiency, a hearing request, or an additional procedural schedule. Therefore, this pleading is timely filed.

**II. PROPOSED PROCEDURAL SCHEDULE**

Staff is in the process of preparing maps necessary for a final recommendation, and therefore proposes the following procedural schedule:

Deadline for the Applicant to respond to Staff's final recommendation.	November 28, 2015


### III. CONCLUSION


