ORDER NO. 5 APPLICATION REMAINS DEFICIENT: ESTABLISHING DEADLINES AND OPPORTUNITY TO CURE

I. **Application**

On June 16, 2015, Childress Creek Water Supply Corporation (Childress Creek) filed with the Public Utility Commission of Texas (Commission) an application to decertify a portion of water certificate of convenience and necessity No. 11000 in Bosque County.

II. Staff Recommendation on Administrative Completeness of the Application

On February 16, 2016, Public Utility Commission of Texas (Commission) Staff filed a supplemental recommendation on the administrative completeness of the application. Commission Staff recommended that the application is not administratively complete because it still contains mapping deficiencies, as specifically described in Commission Staff's February 16, 2016 recommendation. Pursuant to 16 Tex. Admin. Code § 24.8(a), applications are not considered filed until a determination of administrative completeness is made; thus, at this time the application is not considered filed with the Commission.

III. **Proposed Procedural Schedule**

Commission Staff proposed that Childress Creek be given 30 days, until March 17, 2016, to address the mapping deficiencies. Commission Staff proposed to file additional comments regarding completeness of the amended application, along with a proposed procedural schedule, if appropriate, by April 15, 2016.

IV. Finding Application Incomplete and Deficient; Providing Opportunity to Cure

Consistent with Commission Staff's recommendation, Childress Creek's application is deemed administratively incomplete and deficient. On or before **March 17, 2016**, Childress Creek shall amend its application to cure the deficiencies described by Commission Staff. Processing of the application cannot proceed until the requested items are received and reviewed.

On or before **April 15, 2016,** Commission Staff shall file a supplemental recommendation regarding the administrative completeness of the amended application and notice, along with a proposed procedural schedule, if appropriate.
