# ORDER NO. 5 DEEMING APPLICATION ADMINISTRATIVELY COMPLETE, ADDRESSING NOTICE, AND ESTABLISHING PROCEDURAL SCHEDULE

## I. Application

On June 24, 2015, Aqua Texas, Inc. d/b/a Aqua Texas filed with the Public Utility Commission of Texas (Commission) an application to amend its water certificate of convenience and necessity (CCN) No. 13203 and sewer CCN No. 21065 in Montgomery County, Texas.

## II. Administrative Completeness

On January 15, 2016, Commission Staff filed a supplemental recommendation regarding administrative completeness of the amended application and notice, along with a proposed procedural schedule. Commission Staff recommended that Aqua Texas's application, as amended, was sufficient for further review. Consistent with Commission Staff's recommendation, Aqua Texas's application, as amended, is administratively complete.

#### III. Notice

Commission Staff recommended that Aqua Texas proceed with notice as described in Commission Staff's January 15, 2016 filing and the attached memorandum of Debbie Reyes Tamayo and Tracy Montes of the Commission's Water Utilities Division, using the forms attached to Commission Staff's memorandum.

Consistent with Staff's recommendation, Aqua Texas shall provide notice as described using the forms attached to the January 15, 2016 recommendation. Applicant shall file a copy of the actual notice sent and file affidavits evidencing proof of notice by the deadline set forth below.

## IV. Procedural Schedule

The following procedural schedule shall apply:
