APPLICATION OF AQUA TEXAS, SINC. DBA AQUA TEXAS TO AMEND SINC. DBA

AQUA TEXAS' REQUEST FOR EXTENSION OF FINAL PROCEDURAL SCHEDULE

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

COMES NOW, Aqua Texas, Inc. d/b/a Aqua Texas ("Aqua") and files this Request for Extension of Final Procedural Schedule. In support thereof, Aqua would show the following.

On June 24, 2015, Aqua filed an application to amend its water and sewer certificates of convenience and necessity (CCN) Nos. 13203 and 21065 in Montgomery County, Texas to accommodate a request for service to property owned by Pulte Homes ("Application"). On January 22, 2016, the Application was accepted as administratively complete, and on February 24, 2016, Order No. 6 Adopting Final Procedural Schedule was issued.

The Commission did not receive comments or intervention requests in this docket during the required time period. However, Staff has identified additional information needed to complete its technical review of the Application. Therefore, Aqua requests a 30-days extension of the procedural schedule established in Order No. 6 to allow sufficient time for Aqua to work with Staff on this issue so that it may complete its technical review and request approval of the Application. Commission Staff is not opposed to this request.

Aqua respectfully requests that the following deadlines be included in the a new procedural schedule.

Deadline for Commission Staff's recommendation on final disposition or to request a hearing on the merits

May 26, 2016

Deadline for Applicant to respond to Commission Staff's recommendation on final disposition and/or request a hearing

June 2, 2016

Deadline for parties to file proposed notice of approval, including findings of fact, conclusions of law, and ordering paragraphs

June 24, 2016

There is a possibility Aqua may need more time to provide Commission Staff with information it has requested for its technical review. If so, Aqua proposes to report back in 30 days and request a new revised procedural schedule as may be necessary after conferring with Staff.

PRAYER

Aqua Texas, Inc. respectfully requests that the Honorable Administrative Law Judge issue an order approving Aqua's request for a 30-day extension of the existing procedural schedule, setting out the amended deadlines requested herein, and setting a status report deadline for Aqua to use if needed.
