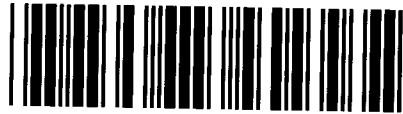

DEEMING APPLICATION SUFFICIENT; ADDRESSING NOTICE AND
ESTABLISHING PROCEDURAL SCHEDULE

I. Application

On July 30, 2015, TexAmericas Center (TexAmericas) and Riverbend Water Resources District (Riverbend) filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Bowie County.

II. Administrative Completeness

On August 31, 2015, Commission Staff filed additional comments on the sufficiency of the amended application and notice. Commission Staff finds that the application and notice, as amended, are sufficient for further review. Consistent with Commission Staff's recommendation, the application and notice are deemed administratively complete.

III. Notice

Commission Staff recommended that the parties provide notice and submit signed affidavits indicating that notice was given, along with a copy of the actual notices issued, within 30 days of the date of notice and last publication date. Consistent with Staff's recommendation, Applicants shall provide notice as described in Commission Staff's August 31, 2015 filing consistent with the criteria outlined in the attached memorandum of Leila Guerrero and Kristy Nguyen of the Commission's Water Utility Regulation Division, using the form attached to the Commission Staff memorandum. Applicants shall file affidavits evidencing proof of notice by the deadline set forth below.


IV. Procedural Schedule

The following procedural schedule is adopted:

Deadline for Applicants to provide the Commission with the Affidavits of Notice	October 2, 2015
Deadline for Comments or Requests for Intervention, and deadline for Intervenors to request a hearing	30 days after Applicants mail or publish notice, whichever occurs later
Deadline for Staff to file an additional procedural schedule with hard deadlines ¹	October 16, 2015
