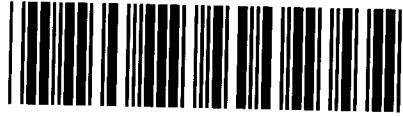

MEMORIALIZING PREHEARING CONFERENCE, SETTING PROCEDURAL

Responses to RFIs filed on rebuttal, intervenors, and Staff are due ten calendar days after receipt. Objections to such RFIs are due at the same time. Motions to compel are due three working days after receipt of objections, and replies to motions to compel are due three working days after receipt of the motion.
