# ORDER NO. 1 REQUIRING COMMENTS ON ADMINISTRATIVE COMPLETENESS AND NOTICE; REQUESTING PROCEDURAL SCHEDULE, AND ADDRESSING OTHER PROCEDURAL MATTERS

### I. Application

On September 21, 2015, the City of Austin (Austin) filed with the Public Utility Commission of Texas (Commission) an application to amend its sewer certificate of convenience (CCN) No. 20636 to remove a portion of area and add same to Aqua Water Supply Corporation's d/b/a Aqua WSC's sewer CCN No. 20962 in Travis County. Austin seeks to remove approximately 32.63 acres of land having zero current customers. The proposed amendment comprises the 78612 and 78617 zip codes.

## II. Requiring Comments on the Administrative Completeness of Application and Proposed Notice

Pursuant to 16 Tex. Admin. Code § 24.8(a) (TAC), by **October 21, 2015**, Commission Staff shall file comments on the administrative completeness of the application and proposed notice. By **October 21, 2015**, Austin and Commission Staff shall file comments/recommendation regarding how this petition should be processed and propose a procedural schedule. Notice of this application will appear in the October 2, 2015, issue of the *Texas Register*.

### III. Discovery

Discovery may proceed informally; however, objections to Requests for Information (RFIs) must be filed and served within 10 days of receiving the RFI. Objections shall include a

statement that negotiations were conducted diligently and in good faith. If the parties are unable to resolve a discovery dispute, a motion to compel a response to an RFI must be filed and served within five (5) working days of receipt of an objection. The motion to compel shall specify the grounds for the motion.

### IV. Filings

Unless otherwise specified, an original and 10 copies of documents relating to this proceeding must be filed with the Commission filing clerk according to 16 TAC § 22.71. A copy of each document filed with the Commission must also be served on all parties as provided in 16 TAC § 22.74. All filings can be accessed on the PUC Interchange, <a href="http://interchange.puc.texas.gov">http://interchange.puc.texas.gov</a>.

All parties shall provide their current addresses, telephone and facsimile numbers, if available, to all other parties and the Commission by filing and serving all parties with such information. Each party shall provide the Commission and all parties with updated address, telephone, and facsimile information if such information changes. The telephone and facsimile numbers will be placed on the service list for the convenience of the parties. Parties are responsible for updating their own service lists to reflect changed information and the addition of any other parties.

### V. Ex Parte Communications

Pursuant to 16 TAC § 22.3(b)(2) ex parte communications with the administrative law judges and presiding officer (collectively, ALJs) are prohibited. Parties shall communicate with the ALJs only through written documents filed with the Commission's Filing Clerk and served on all parties. Questions concerning this order or any other order must be submitted in writing, filed with the Commission, and served on all parties of record.
