
**OVATION ACQUISITION I, LLC, OVATION ACQUISITION II, LLC,
AND SHARY HOLDINGS, LLC'S NOTICE OF CONFIDENTIAL RESPONSE TO
COMMISSION STAFF'S SECOND REQUEST FOR INFORMATION**

On October 21, 2015, Ovation Acquisition I, LLC, Ovation Acquisition II, LLC, and Shary Holdings, LLC (collectively, Applicants) filed its response to Commission Staff's (Staff) Second Request for Information (RFI). Exhibits STAFF 2-5, 2-8, 2-11, and 2-12 (HSPM) contain commercially sensitive information that is considered confidential. Applicants hereby designate Exhibits STAFF 2-5, 2-8, 2-11, and 2-12 (HSPM) as Highly Sensitive Protected Material under the Protective Order adopted in this proceeding. This notice is filed to comply with the requirements of paragraph 4 of the Protective Order relating to the claims of exemption from public disclosure pursuant to the Texas Public Information Act (TPIA).

Exhibits STAFF 2-5, 2-8, 2-11, and 2-12 (HSPM) contain information that is Highly Sensitive Protected Material exempt from public disclosure pursuant to TEX. GOV'T CODE §§ 552.101, 552.104, and/or 552.110. This material may include, but is not limited to, information that is of a highly commercial and sensitive nature involving company business operations that, if released, would give advantage to a competitor. The public disclosure of any market-sensitive commercial information could cause competitive harm to Applicant's counterparts in contractual business relations and would be contrary to the state legislative policy in the Public Utility Regulatory Act.

The undersigned counsel for Applicants has reviewed the information sufficiently to state in good faith that the information is exempt from public disclosure under the TPIA and merits the confidential and highly sensitive protected material designation.
