## COMMISSION STAFF'S SETTLEMENT CONFERENCE INFORMATION

#### I. BACKGROUND

On January 11, 2016, the State Office of Administrative Hearings (SOAH) Administrative Law Judge (ALJ) issued SOAH Order No. 2 memorializing the prehearing conference, establishing the procedural schedule and providing notice of the hearing on the merits. The parties were ordered to attend a settlement conference in person or via phone on January 29, 2016. Staff was directed to provide a room, arrange for a phone bridge and to file a pleading informing parties of the related information by January 19, 2016. This pleading is therefore timely filed.
