**PARTIES PROPOSED PROCEDURAL SCHEDULE**

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest and files this Parties Proposed Procedural Schedule. In support thereof, Staff shows the following:

**I. BACKGROUND**

On September 30, 2015, J. Hinken (Complainant) filed a complaint against Bastrop West Water and its owner, Paul Klaus (BWW) pursuant to Texas Admin. Code § 22.242 (TAC). On November 9, 2015, the Commission referred this case to the State Office of Administrative Hearings (SOAH). SOAH Order No. 5 required parties to submit an agreed, modified procedural schedule to comply with Order No. 4 by May 27, 2016.

**I. PROPOSED PROCEDURAL SCHEDULE**

Parties have conferred and jointly propose the following procedural schedule.

Deadline for objection to direct and Rebuttal Testimony	October 3, 2016
Hearing on the merits	October 19-20, 2016

Staff respectfully requests that the procedural schedule proposed above be adopted.




